This update confirms that January 12<sup>th</sup> will not be the date for the Borough Council's Planning Applications Committee (PAC) meeting, to consider the planning applications for West End, as shown here \*

- South of King's Road, 84 houses by the William Lacey Group (14/0532)
- Off Beldam Bridge Road, 85 houses by Taylor Wimpey (14/0594)
- South of Beldam Bridge Road, 3 large houses by Redrow Homes (14/0451)

The next possible date for the PAC meeting is Monday 9<sup>th</sup> February. Please make this a priority calendar date in preparation for attendance at this meeting.

Those of us who have made representation to the Borough Council will be advised two weeks in advance of the meeting. WEAG will of course advise all supporters once the date is confirmed with us.

**ONCE** the date is confirmed, we will be seeking volunteers, as stated previously, to deliver leaflets in the east of the village in order to alert/remind residents of the date of the PAC meeting. We thank those of you who have already agreed to help and would like to hear from others who would be willing to do so, subject to availability once we have a date.
